List of Higher Educational Institutions (HEIs) recognized to offer Online programmes for academic year 2023-24, academic session beginning July-August, 2023 and onwards

- (I) On the basis of applications received under University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments, list of eligible HEIs recognized to offer Online programmes for academic year 2023-24, academic session beginning July-August 2023) and onwards is enclosed herewith.
- (II) In addition to (I) above, the list of Higher Educational Institutions (HEIs) entitled to start full-fledged Online Programmes without prior approval of the UGC, as per provisions stipulated under regulation 3(B)(a) of the University Grants Commission (Open and Distance Learning Programmes and (Online Programmes) Regulations, is already uploaded on UGC Web portal.
- (III) Programmes under the ambit of the Regulatory Authorities have been considered on the basis of communication/recommendation received from respective Regulatory Authority. The HEI shall abide with the conditions such as number of seats, valid academic year etc. mentioned in the relevant Regulatory Authority letter.
- (IV) The HEIs shall ensure the compliance of entry level qualification, mode of admission, duration of programme (minimum & maximum) and number of credits as per UGC Notification on Specification of Degrees 2014, UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and other instructions/notices issued by UGC and other statutory/ regulatory bodies from time to time.
- (V) Provision stipulated under Regulation 3(B)(a) of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 is as under:-
 - ".....a Higher Educational Institution having National Assessment and Accreditation Council (NAAC) valid score equal or more than 3.26 or having rank in Top 100 in University category of National Institutional Ranking Framework at least twice in three preceding cycles shall be permitted to enroll International Learners also..."
- (VI) Commission in its 571st meeting held on 25th July, 2023 has decided that last date of admission and last late for uploading of student admission details on the UGC-DEB web portal for offering ODL and Online programmes for academic session July-August, 2023 will be as under:
 - Last Date for Admission: 30th September 2023.
 - Last Date for Submission of Student Data on the Portal: 15th October 2023.
- (VII) The Higher Educational Institutions have submitted an affidavit to the effect that in case any information, documentary evidence submitted/produced by the Higher Educational Institution is found to be false or wrong at a later stage or in case there is any violation of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments by the HEI, the Higher Educational Institution shall be solely liable and responsible for any such contravention/violation and

for any consequences thereof (including career consequences of Learner) In such events, the HEI may also be subject to the consequences stipulated under Regulation 7 of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 (including any amendments thereto).
